The proposed Goods & Services Tax (GST), recently cleared for implementation in 2017 will be positive for the Indian Cross Industry. Benefits from improved transparency and ease of doing business would also improve supply chain efficiency over the longer term. The modus operandi of implementation of GST could have a short-term impact on the cash flow cycle pertaining to payment of indirect taxes; under the GST system, updating / reconciliation and payment by the seller on the GST network system would be required before the buyer can input-tax credit, effectively avail elongating the working capital cycle related to indirect tax payments
